Strengths:

PI and PII students performed well clinically and didactically. While the standard of success clinical final scores may not reflect this, the scores have gotten better with each offering. WCC had 100% pass rates on the May 2023 and August 2023 RDA Board exams! Both groups of students are able to obtain/maintain employment. Pathway I students are highly sought after. The faculty receive calls weekly seeking WCC graduates for employment or clinical rotations.

Weaknesses:

While PII students struggle to pass on their first attempts, we anticipate improvement with submission of increased practice attempts, allowing additional practice time at the mid-term and no longer allowing virtual mid-terms. We also updated the study guides and will continue to host a final review session virtually.

With the changes in data collection, we were better able to determine the numbers of attempts in order to measure standard of success.

It was determined that additional practice was needed on the Viade models. In S/S 2023 for PI and Fall 2023 for PII we required PI students to complete a practice attempt each week and the PII students need to submit practice attempts every other week and evaluate their own performance. We have also implemented every other week review sessions were available to all PII students.

The benchmark was set that 85% of the students who elect to take the exam would pass. The benchmark was reached with 89% of the students who took the exam, passed the exam. Of those students that retook the exam, 100% passed.

Benchmark: All students will achieve at least 80% on multiple-choice section of the final exam. All students will achieve passing scores on the performance portion of the final exam.

Pathway I students do well didactically while Pathway II students perform better clinically. This is not surprising given that Pathway II students have been working in the field for at least two years. Both groups of students are able to pass the board exam and obtain/maintain employment. Pathway I students are highly sought after. The faculty receive calls weekly seeking WCC graduates for employment or clinical rotations.

Weaknesses:

Pathway I students were weaker on the DEN 204 clinical final.

The 2018 and 2019 cohorts were weaker on their clinical evaluations than in later years. In 2020 and 2021 students did not go to the dental school and spent more time preparing prior to going to an external rotation.

Pathway II students were weaker on the DEN 204 written final.

In Fall of 2018, a clinical mid-term was added for DEN 204. This greatly increased clinical final success rates. Students started practicing earlier for the clinical final and were able to receive feedback earlier on.
Additional videos were added to the course and the pandemic increased the need for this as well. The faculty provide all the lectures online and much of the two days on campus are spent hands-on now.

For Pathway I students, additional clinical activities will be added in the Fall semester to DEN 110 and 112 as well as the Winter semester in DEN 131.
For Pathway I students a dental clinic boot camp will continue to be implemented prior to the start of the WCC Dental Clinic. Students will be kept at WCC initially and then complete an external rotation at the endof the Winter semester. The several weeks between the WCC clinic and the start of their external rotations may have proved to be too long.

Results on the RDA exam continue to show that WCC graduates pass rates are higher than candidates from other Commission on Dental Accreditation (CODA) accredited DA programs in Michigan. Employers and graduates express their satisfaction with the program and make recommendations.

Weaknesses:

As indicated, DEN 202 clinical evaluations did not meet the standard of success and in 2014/2015, the program completion was lower than in the following years.

With regards to the DEN 202 evaluations, the standard of success is high expecting all students to achieve 85% or higher. However, the faculty have no desire to lower our expectations and will continue to strive to meet that level of success. The common denominator seems to be a communication issue on the part of the students as opposed to their clinical skill level. Communication is stressed in every component of the program and will continue to be incorporated in the future.

Concerning the completion rates, the faculty are and will be more proactive with the help of student success coaches.
